## SPEAKERS' BIOGRAPHIES

**Taras Berezovets** has served as Director of Strategic Consulting at Berta Communications since 2010 and has been a member of the UK-Ukraine Partnership Network since 2004. Between 1998 and 2004, Mr. Berezovets, a Royal College of Defence Studies (London) alumnus, served in various capacities in the National Security and Defense Council of Ukraine; during the period, he worked closely with Ukraine's iconic geo-strategist Volodymyr Horbulin.

**Janusz Bugajski** is a Senior Fellow at the Center for European Policy Analysis (CEPA) in Washington DC and host of television shows broadcast in the Balkans. Bugajski has authored 20 books on Europe, Russia, and trans-Atlantic relations and is a columnist for several media outlets. His recent books include *Eurasian Disunion: Russia's Vulnerable Flanks* (with Margarita Assenova) (2016); *Conflict Zones: North Caucasus and Western Balkans Compared* (2014); *Return of the Balkans: Challenges to European Integration and U.S. Disengagement* (2013); and *Georgian Lessons: Conflicting Russian and Western Interests in the Wider Europe* (2010).

**Luke Coffey** is presently Director of the Allison Center for Foreign Policy Studies at The Heritage Foundation. In his current position, he is responsible for directing policy research for the Middle East, Africa, Russia and the former Soviet Union, the Western Hemisphere, the Arctic region, and NATO. Immediately prior to his work at Heritage, Mr. Coffey was posted as a special adviser to Britain's Ministry of Defence. Earlier, he served as an officer in the United States Armed Forces, with deployments in South Europe and Afghanistan.

**Valeriy Chaly** presently serves as Ambassador Extraordinary and Plenipotentiary of Ukraine to the United States. He came to the post immediately after having held the position of Deputy Head of Administration of the President of Ukraine. Before his political and foreign services appointments, Amb. Chaly worked a number of years as Deputy Director General of Ukraine's leading NGO, the Razumkov Center, gaining recognition in Ukraine as well as internationally for his efforts at the institution

**William Courtney** is an adjunct senior fellow at the RAND Corporation and executive director of the RAND Business Leaders Forum. He is also president of the U.S.-Kazakhstan Business Association, which represents U.S. exporters to and investors in Kazakhstan. In 2014 he retired from Computer Sciences Corporation as senior principal for federal policy strategy. From 1972 through 1999, he was a foreign service officer in the U.S. Department of State. He co-chaired the U.S. delegation to the review conference that prepared for the 1999 Istanbul Summit of the Organization for Security and Cooperation in Europe and advised in the reorganization of U.S. foreign affairs agencies, mandated by the Foreign Affairs Reform Act of 1999. Earlier he served as special assistant to the President for Russia, Ukraine, and Eurasia and as Ambassador to Georgia, Kazakhstan, and the U.S.-Soviet commission that implemented the Threshold Test Ban Treaty.

**Orest Deychakiwsky**, until his very recent retirement, was a senior staff advisor at the U.S. Commission on Security and Cooperation in Europe whose country responsibilities included Ukraine, Belarus and Bulgaria; he served as a member of U.S. delegations to numerous OSCE/CSCE meetings and as an international election observer in Ukraine, Belarus, Russia, Bulgaria, Slovakia and Bosnia. Mr. Deychakiwsky has authored or co-authored a sizable number of speeches, statements, resolutions, and articles on issues pertaining to Ukraine or U.S.-Ukrainian relations.

**Andrew J Futey**, in September 2016, was elected to a four year term as President of the Ukrainian Congress Committee of America, the representative organization of over 1.5 million Americans of Ukrainian descent; he concurrently serves as a Vice President of the Ukrainian World Congress. Mr. Futey brings more than 20 years of extensive government and campaign experience as President of Andrew J Futey & Associates. His firm provides public policy and government relations consulting, strategic planning, public affairs and campaign development strategies at the international, federal, state and local levels. His clients have included Ohio and out-of-state Fortune 500 Companies, Major Corporations, Small Businesses, Community Non-Profit Organizations, Professional and State Associations and Governmental Entities.

**Bohdan Futey** has served as Judge of the United States Court of Federal Claims since 1987. Judge Futey is actively involved with Democratization and Rule of Law programs organized by the Judicial Conference of the United States, the Department of State, and the American Bar Association in Ukraine and Russia. He has participated in judicial exchange programs, seminars, and workshops and has been a consultant to the working group on Ukraine's Constitution and Ukrainian Parliament.

**Katie Fox** is deputy director of the Eurasia department at NDI. Prior to joining the Institute more than 15 years ago, Ms. Fox was legislative director for a large labor union as well as serving as an aide to two U.S. senators and a congressman. In her current role, Ms. Fox oversees NDI election monitoring, civic organizing and political party development programs in Ukraine, Russia, Belarus and Moldova. She has monitored elections in Bosnia, Georgia, Kyrgyzstan, Russia and Ukraine, and served on a NDI pre-election delegation to Ukraine in 2007.

**Nile Gardiner** is Director of The Heritage Foundation Margaret Thatcher Center for Freedom. A recognized authority on transatlantic relations, Dr. Gardiner has advised the executive branch of the U.S. government on a range of key issues. His policy papers are read widely on Capitol Hill, where he is regularly sought after for advice on major foreign policy matters. He has testified several times before Congress, and frequently briefs delegations of political leaders and journalists from across the world. He frequently appears as a foreign policy analyst and political commentator on national and international television and radio, including Fox News Channel, CNN, BBC, Sky News, and NPR.

**Lubomyr Hajda** is Associate Director of the Ukrainian Research Institute at Harvard University. A historian with a Ph.D. from Harvard University, he has taught at Harvard and the University of Massachusetts-Amherst. From 1978 to 1992 he held the position of Academic Coordinator of Harvard's Master's program in Soviet studies. Among Dr. Hajda's publications are the entry on Ukrainian history in the Encyclopaedia Britannica (15th ed.), The Nationalities Factor in Soviet Politics and Society (with Mark Beissinger), and Ukraine in the World: Studies in the International Relations and Security Structure of a Newly Independent State.

**Antin Heraschenko** was elected to Verkhovna Rada of Ukraine's VIII convocation on Oct. 26, 2014, having ranked 21st on the 'National Front' party list. Immediately prior to his election, he served as Advisor to the Minister of Internal Affairs of Ukraine Arseniy Avakov. On January 21, 2017, thirteen months after the Investigative Committee of the Russian Federation put Mr. Herashchenko on their watch list, the head of the Security Service of Ukraine Vasiliy Hrytsak announced that the SBU officers had prevented an attempt on the life of the Ukrainian MP.

**Glen Howard** is President of The Jamestown Foundation; he is fluent in Russian, proficient in Azerbaijani and Arabic and is a regional expert on the Caucasus and Central Asia. His articles have appeared in The Wall Street Journal, the Central Asia-Caucasus Analyst, and Jane's Defense Weekly; he has served as a consultant to private sector and governmental agencies, including the U.S. DOD, the National Intelligence Council and major oil companies operating in Central Asia and the Middle East.

**Adrian Karatnycky** is a senior fellow with the Atlantic Council's Program on Transatlantic Relations and managing partner of Myrmidon Group LLC, a NY-based consultancy that works with investors seeking entry into the complex emerging markets of Ukraine and Eastern Europe. He is a founder and co-director of the Ukrainian-Jewish Encounter. From 1993 to 2004, he was president and executive director of Freedom House, during which time he developed programs of assistance to democratic and human rights movements in Belarus, Serbia, Russia, and Ukraine.

**Phillip Karber** is President of the Potomac Foundation; he was named to this position in 2012, having been a Senior Fellow since the Foundation's inception in 1988. Dr. Karber is an internationally recognized expert in defense and national security matters; an accomplished business executive; and an academic. He has prepared studies on defense strategy for the highest levels of the U.S. government; advised major NATO governments on defense issues; headed BDM Corporation's International Division; and taught courses in national security and military affairs at Georgetown University, where he also was founding director of the Asian Arms Control Project.

**Adrian Karmazyn** is a Special Advisor for Strategic Communications and Development at the U.S.-Ukraine Foundation. From 2005 to 2015 he served as Chief of the Ukrainian Service of the Voice of America, during which time VOA significantly expanded its impact and audience in Ukraine's television market. Prior to his appointment to a management role at VOA, he worked as a journalist in the Ukrainian Service.

**Aleks Mehrle** is a licensed attorney and experienced business development professional, primarily in areas related to innovation, technology and sustainable energy. His primary responsibilities for UGTI include securing the participation and coordinating collaboration between public and private stakeholders in Ukraine with leading strategic US and other partners across a variety of sectors including education, energy, finance and innovation. To meet these obligations, Mr. Mehrle draws on his past experience as Licensing Counsel for a global patent licensing company where he is a lead negotiator for all active patent licensing programs

and developed patent and technology monetization opportunities through partnerships with universities, technology companies, law firms and the financial industry.

**Brian Mefford** is a nonresident Senior Fellow at the Atlantic Council's Dinu Patriciu Eurasia Center. He is a business and political consultant who is based in Kyiv, Ukraine. Named by the Kyiv Post as one of the twenty "Most Influential Expats in Ukraine," he has lived and worked in Eastern Europe continuously for over fifteen years. In the spring of 1999, Mr. Mefford joined the International Republican Institute (IRI) as a resident program officer in Ukraine. From 1999 until 2007, he trained, advised, and consulted thousands of political activists and governmental officials in Ukraine, Georgia, Azerbaijan, Moldova, Belarus, Kyrgyzstan, Romania, Croatia, Serbia, and Macedonia on a variety of topics related to political party development. During 2008, Mefford served as IRI Ukraine country director and opened its Odessa regional office.

**William Miller** is presently a Senior Scholar at the Kennan Institute, Woodrow Wilson International Center. Earlier, he served as the second US Ambassador to Ukraine. During his tenure, Ambassador Miller was eyewitness to some of the most fundamental transformations of the Ukrainian State, including the ratification of Ukraine's Constitution and the accession of Ukraine into the NATO Partnership for Peace program.

**Steven Nix** Esq. is Director of the Eurasian Division at the International Republican Institute. From 1995 to 1997, Mr. Nix served as Outside Legal Counsel for the Ukrainian Parliament's Committee on Legal and Judicial Reform. Upon his return to the U.S., he accepted a position as Senior Democracy Specialist at USAID, where he assisted in the design and implementation of democracy programs in Eastern Europe and the Newly Independent States.

**Tamara Gallo Olexy** has just completed her second term as President of the Ukrainian Congress Committee of America (UCCA), the representative organization of nearly one million Americans of Ukrainian descent, and has returned to work heading the National Office of the UCCA in New York. In the early nineties, Ms. Gallo Olexy was director of the Ukrainian National Information Service bureau in Washington, DC and therefore had a uniquely convenient vantage point from which to observe key events in the modern Ukrainian state's formative history.

**Nolan Peterson** is the foreign correspondent for The Daily Signal, the news site of the Heritage Foundation. He is based in Kyiv, Ukraine. Peterson's work has also appeared on Newsweek, the National Interest, Fox News, BBC, CNN and other outlets. Peterson has reported extensively from the front lines in eastern Ukraine since 2014 and was one of the first foreign journalists to embed with the regular Ukrainian army in combat. Peterson is a former U.S. Air Force special operations pilot, and has also reported from the front lines in Iraq and Afghanistan, throughout Eastern Europe and recently spent several months on assignment in the Himalayas reporting on Tibetan freedom fighters. He is writing a book about his experiences covering the Ukraine war.

**Andriy Parubiy** is Speaker of the Verkhovna Rada of Ukraine. In the 2007 parliamentary elections, he was voted into the Ukrainian parliament; he was re-elected in 2012. From December 2013 to February 2014, he served as commandant of Euromaidan. In March 2014, Mr. Parubiy was appointed Secretary of the National Security and Defense Council of Ukraine. As Secretary of the Council, he oversaw the "anti-terrorist" operation against pro-Russian separatists in eastern Ukraine during the June-August phase, when Ukrainian forces proved capable of effective counter strikes against enemy forces. In October 2014, he returned to the Rada on the Narodnyj Front ticket and was elected to the position of First Deputy Speaker; he assumed his present position on April 14, 2016.

**Herman Pirchner**, in 1982, became the founding President of the American Foreign Policy Council (AFPC), a non-profit public policy organization headquartered in Washington, DC. Under his leadership, AFPC has hosted the Washington visits of hundreds of foreign officials, ranging from the Prime Minister of Malta to the Prime Minister of Russia; conducted hundreds of briefings for members of Congress and their staffs; and organized dozens of fact-finding missions abroad for current and former senior American officials. AFPC's publication program includes the sponsorship of numerous articles, monographs and books; in recent years, AFPC authors have appeared in the Washington Post, the New York Times, the Financial Times, the Washington Times, the Wall Street Journal (including the European and Asian editions), the Baltimore Sun and the US News & World Report, among other prominent newspapers and magazines.

**Roman Popadiuk**, the former U.S. Ambassador to Ukraine, is a principal at Morgan Lewis Consulting. A retired member of the career Senior Foreign Service, Dr. Popadiuk brings more than 30 years of experience in the areas of national security, political risk analysis, communications strategy and energy policy, including serving on the National Security Councils of Presidents Ronald Reagan and George Bush. With his vast

experience and contacts that span the globe, he brings a unique insight into international political and business matters.

**Myron B. Rabij** Esq. is a Global Partner with Dentons, the world's largest international law firm, in its Kyiv and New York offices and is the Head of both Dentons Energy and Natural Resources Practice and Real Estate Practice in Ukraine. Mr. Rabij specializes in corporate/M&A, upstream oil and gas and alternative energy, complex commercial real estate and strategic advising to clients; he has been representing international and Ukrainian clients for over 22 years in complex negotiations of joint ventures, cross-border acquisitions, construction and development, hotel management, international arbitration, and on general matters of Ukrainian corporate law.

**Stefan Romaniw** OAM serves as General Secretary of the Ukrainian World Congress, the entity formally tasked with representing the global Ukrainian Hromada. Mr. Romaniw concurrently holds the position of Executive Director of Community Languages Australia. He served successive terms as Chairperson of the Victoria Provincial Multicultural Commission. In his role as UWC General Secretary, he has performed double duty as Chair of the International Standing Committee on the 1932-33 Holodomor; his myriad and tireless efforts to highlight the great Ukrainian tragedy globally have received wide praise.

**William J. Schneider**, Jr. has served in a number of prominent positions in the US government and major DC policy think tanks. He held the post of Under-Secretary of State for Arms Control and International Security Affairs in the Reagan administration, and later became a member of the Project for the New American Century (PNAC). In 2002, Dr. Schneider was selected by Secretary of Defense Donald Rumsfeld to chair the Defense Science Board, where he served throughout the younger Bush's presidential tenure. He is currently a senior consultant to the U.S. Government's Departments of Defense, Energy, and State.

**Viktoriya Sereda** is presently a MAPA Post-Doctoral Fellow at the Harvard Ukrainian Research Institute. Concurrently, she holds the rank of Associate Professor in the Department of Sociology at Ukrainian Catholic University in Lviv, Ukraine. Between 2011-2015, Dr. Sereda served as coordinator of a seminal qualitative sociological survey: Region, 2015 Nation and Beyond. An Interdisciplinary and Transcultural Reconceptualization of Ukraine, supervised by University of St. Gallen (Switzerland-Ukraine).

**Yuri Sergeev** is currently Senior Fellow at Yale University's MacMillian Center. Prior to his present appointment, he served nearly three decades as a Ukrainian diplomat. Among his most prominent postings, Dr. Sergeev served as Ukraine's envoy to Greece and head of the Directorate General for Foreign Policy of the Administration of the President of Ukraine (1997-2003), envoy to France and, concurrently, the country's permanent representative to UNESCO (2003-2007) and Permanent Representative of Ukraine to the United Nations (2007-2015). As Ukraine's voice in the UN, he led the country's diplomatic efforts to highlight Russia's illegal annexation of Crimea and Russia's continuing "Hybrid War" against Ukraine in UA's industrial heartland---the Donbas region.

**Keith Smith** is currently Senior Fellow at the Center for European Policy Analysis; immediately prior to that appointment, he was Senior Advisor in the Europe Division at the Center for Strategic and International Affairs (CSIS). In 2000, Ambassador Smith retired from the State Department's Foreign Service after serving from 1997 to 2000 as the American Ambassador in Lithuania. In Europe, he was also posted to Hungary (twice), Norway and Estonia.

**Vlad Socor** is a Senior Fellow of the Washington-based Jamestown Foundation and its flagship publication, Eurasia Daily Monitor (1995 to date), where he writes analytical articles on a daily basis. An internationally recognized expert on the former Soviet-ruled countries in Eastern Europe, the South Caucasus, and Central Asia, he covers Russian and Western policies, focusing on energy, regional security issues, Russian foreign affairs, secessionist conflicts, and NATO policies and programs. Mr. Socor is a frequent speaker at U.S. and European policy conferences and think-tank institutions; as well as a regular guest lecturer at the NATO Defense College and at Harvard University's National Security Program's Black Sea Program.

**Ulana Suprun**, M.D. is the acting Minister of Health of Ukraine, founder and former director of the NGO Patriot Defence and former director of Humanitarian Initiatives for the Ukrainian World Congress. In July 2015, President Poroshenko awarded Dr. Suprun and her husband Mark Ukrainian citizenship for their Patriot Defense efforts. In September 2015, she was appointed director of the School of Rehabilitation Medicine at the Ukrainian Catholic University. She also was invited to be a consultant for the Ukrainian Parliamentary Committee on Health and worked on new laws regarding Rehabilitation and Emergency Medicine. On July 27, 2016 Ukraine's Cabinet of Ministers approved a resolution appointing Dr. Supun to her present position.

**Roger F. Wicker** has represented Mississippi in the United States Senate since December 2007. He is a member of the Senate Republican leadership team, and served as chairman of the National Republican Senatorial Committee during the 114th Congress. As a member of the Senate Armed Services Committee, he chairs the Subcommittee on Seapower. Equally notable, Sen. Wicker is the current Chairman of the U.S. Helsinki Commission and Chair of the Committee on Political Affairs and Security in the OSCE's Parliamentary Assembly.

**Volodymyr Zaryckyj** is Executive Director of the Center for US-Ukrainian Relations. The Center provides "informational platforms" or venues for senior-level representatives of the political, economic, security, diplomatic and cultural/academic establishments of the United States and Ukraine to exchange views on a wide range of issues of mutual interest, and to showcase what has been referred to as a "burgeoning relationship of notable geopolitical import" between the two nations. Dr. Zaryckyj completed his undergraduate and graduate work at Columbia University; he taught political science at NYU for nearly three decades before moving on in recent years to do postdoctoral research work on Eastern Europe.
