15:50 – Panel I : The Ukrainian political scene after the presidential election. Consolidation of the political system or a threat to democracy?

Victor Yanukovych's political party was able to put together a parliamentary majority soon after his victory in the presidential election, despite doubts about the constitutionality of the move. Significant changes were made in the state administration with loyalty to Yanukovych as the main criterion for appointments. There were attempts to strengthen state control over the media. Two important private broadcasters were deprived of their license to carry public affairs and news programs in certain regions. The police, the SBU and other security services have grown in importance. The opposition, which is divided, is being marginalized. Some Polish and German analysts described this state of affairs as a consolidation of state power needed to implement painful social and economic reforms brought about by the financial crisis. However, others are talking of a return to authoritarianism in Ukrainian politics. This panel will present views of Polish, German and Ukrainian experts on this issue as well as provide political scenarios for Ukraine in 2011.

Those who see the present Ukrainian government as being pro-Russian are being proved right. The government has prolonged the lease for the Russian Black Sea fleet in Crimea till 2040. It has accepted the status quo in Transnistria leaving Russian troops as the only peace keepers in the area and signed the numerous strategic agreements on economic cooperation with Russia. On the other hand the government has placed store by its pro UE policies and is preparing to sign an Association Treaty with the European Union. It is also maintaining its military cooperation with NATO.
